#### Article 1 Introductory Provision

1) Upon Resolution of the Government of the Czech Republic of 30 April 2020 N. 491 on introducing crisis measures, the Rector of the University of Pardubice issued the following provision effective from 11 May 2020.

#### Article 2 Up-to-Date Limitations

1) Personal participation of students in classes at the university pursuant to Act 11/1998 Sb. on universities, as amended (the Act on Universities) is enabled only on the condition that a maximum of 15 students in a group are present. This limitation does not apply to the clinical and practical sessions.

## Article 3 Hygienic Measures

- 1) Students and academic staff may participate in the study in compliance with Article 2 hereof only under the following conditions:
- They have no acute symptoms of an infectious disease (e.g. fever, cough, dyspnea, loss of taste or sense of smell etc.),
- They are obliged to wear protective aids,
- They are not under quarantine at the given time,
- Before the first entry to the educational institution students provide a written affidavit of nonexistence of an infectious disease which is in Annex 1 to this Provision.
- 2) The relevant faculties undertake to record students' affidavits in compliance with Article 1 hereof.

#### Article 4 Organisational Requirements

- 1) Classrooms/Laboratories/Studios will be prepared in a way providing for the sufficient social distancing between students and academic staff (a minimum of 2 metres). The same distance must be kept also in the joint parts of the faculty / university.
- 2) Students appear in the classes at the stipulated time to minimize the risk of infection spread.
- 3) Students stay in the university premises for the essential time, i.e. for the relevant study session and leave immediately after its termination.

### Article 5 Final Provisions

- 1) Conditions for educational activities at the University of Pardubice will be further announced in the News section on the University Intranet in compliance with the measures taken by the Government of the Czech Republic. In connection with the foregoing, the Rector imposes on the Deans and other concerned supervising staff the obligation to implement the above indicated measures within their competences and to communicate them to the students and concerned employees. Resolutions about change of schedule and further course of the semester primarily fall within competence of individual faculties. It is essential to consider the needs and importance of all steps taken in regard to the specifics of each faculty.
- 2) The Provision becomes valid upon the Rector's signature and comes into effect on 11 May 2020.
- 3) With effect from 11 May 2020, the Rector's Provisions N. 2/2020, 5/2020 and 6/2020 are cancelled.
